- 2.3 Students will conduct Industrial Internships and Project at the organization and institute will allow the industry to conduct the campus recruitment at our institute.
- 2.4 Lab set up at R. C. Patel Polytechnic, Shirpur by mutual understanding.
- 2.5 Scope of training for at least 100 trainees a year.
- 2.6 Conduction of Workshops, Training sessions, Guest Lectures, Industrial Visits at either organization or institute as per the need and availability of required resources.
 - 3. CONFIDENTIALITY:
 - 3.1 Both parties shall not use the name and brand of the other party in any advertisement or make any public announcement without the prior written approval of the other.
 - 3.2 Either party can terminate this agreement by giving 30 days prior written notice to the other party.
 - 3.3 Any changes in implementation procedures which are not as per present MOU will be discussed and will be incorporated in agreement with two parties.
 - 3.4 The activities of this MOU must be carried out in accordance with appropriate laws and regulations of Institute and the industry.
